Interested contractors are invited to tender for ***only one*** project. The minimum requirement for prospective tenderer is as follows:

- a) Must be registered by National Construction Authority (NCA) Water works category.
- b) Must provide a bid bond of 2% of the quoted sum from a commercial bank or an insurance firm approved by PPOA.
- c) Must provide financial standing, audited accounts for the last two years and reference letter from the bank
- d) Must provide valid Tax Compliance Certificate.
- e) Must provide Evidence of adequate equipment and key personnel.
- f) Must Show proof of works of similar magnitude undertaken within the last five (5) years.
- g) Must provide PIN and VAT certificates.
- h) Must provide proof of registration as a company
- i) Must provide Valid business permit
- j) Dully filled business questionnaire and Form of tender
- k) Must provide relevant Ministry certificate

Further, a tender from the following tenderers shall be treated as non-responsive and therefore subject to automatic disqualification.

- a) A tender from a tenderer whose ongoing projects is/are behind schedule and without any approved extension of time.
- b) A tender from a tenderer who has been served with default notice on on-going project/s or terminated from contract

Complete set of detailed Tender documents shall be obtained by interested Bidders upon payment of a non-refundable fee of KShs.1, 000/= (Kenya Shillings One Thousand Only) per set of Tender Document to Cash Offices located at AFC Building, Baringo County Government, Kabarnet (along Eldoret Road); **during Official Working Hours (8.00 a.m. to 5.00 p.m.):** -
