- Must be registered by National Construction Authority (NCA) building, category except for Kabarnet Hospital Sewerage Lagoon Rehabilitation which requires NCA for water works.
- Must provide financial standing, audited accounts and bank statements for the last two years.
- Must provide valid Tax Compliance Certificate.
- Must provide Evidence of adequate equipment and key personnel.
- Must Show prove of works of similar magnitude undertaken within the last five (5) years
- Must provide PIN and VAT certificates.
- Must provide Prove of registration as a company
- Must provide Valid business permit
- Dully filled business questionnaire and Form of tender

Further, a tender from the following tenderers shall be treated as non-responsive and therefore subject to automatic disqualification.

- A tender from a tenderer whose ongoing projects is/are behind schedule and without any approved extension of time.
- A tender from a tenderer who has been served with default notice on on-going project/s or terminated from contract
- A tender from a tenderer with on-going project(s) with Baringo County Government

Preference will be given to special from groups from the county and local companies in accordance with the regulations.
